DTC has been notified by The Bank of New York, the depository bank for the Europe 2001+ HOLDERS, that a dividend has been declared for LM Ericsson Telephone, a component of the Europe 2001+ HOLDERS. U. S. beneficial owners, as defined in the double taxation convention between the United States and Sweden, are entitled to a reduced tax treaty rate of **15% (or 0% for qualified U.S. pensions)** rather than the statutory withholding tax rate of **30%**, with the exception of owners whose shares are effectively connected with the beneficial owner's permanent establishment in Sweden.

Participants can use DTC's Elective Dividend System (EDS) function over the Participant Terminal System (PTS) to certify all or a portion of their position entitled to the applicable withholding tax rate. Participants are urged to consult the PTS function TAXI (TAXINFO) before certifying their elections over EDS.

**NOTE: THE DEADLINE FOR CERTIFYING OVER EDS IS APRIL 16, 2008.**
