REMINDER

Beginning Monday, July 2, 2007 for DAM deposits DTC will continue to accept regular deposits, but not legal deposits with legal documentation attached if the transfer agent for the issue does not participate in the Paperless Legal Program. Firms that have legal transfers for issues whose transfer agent does not participate in the program will need to present those shares and accompanying documentation directly to the transfer agent. DTC first notified its participants of this date in Important Notice B#1484-07 published on April 27, 2007 and again in Important Notice B#1738-07, published on June 12, 2007.

Attached for your review is the current listing of those agents who participate in the Paperless Legal Program. DTC periodically publishes updated listings of the Paperless Legal transfer agents. DTC also provides its participants with a weekly file of these transfer agents and the issues they transfer. This file, **PLAQSP**, can be obtained by contacting Martin Shannon at mshannon@dtcc.com. Participants can also get this information by accessing the *STP Paperless Agent CUSIP Report* on SMART/Search. Additionally, deposits covered by a Paperless legal transfer agent will have the letters "PLA" printed on the DAM deposit tickets.

Legal documents covered under the Paperless Legal Program must not accompany deposits for Paperless Legal transfer agents. Participants must detach and retain this paperwork prior to depositing the certificates at DTC. This does not include legal deposits with a market value of \$14 million or greater, for which all transfer agents require legal paperwork.
