DTCC Learning is pleased to announce new dates for its FOCUS on the Web settlement course offerings.

Stock Loan and Repurchase Agreement (REPO) Problem Resolution is a one-hour Webinar session, led by a DTCC Learning training expert, designed to provide learners with an understanding of the concepts, terminology and fundamentals of stock loan and REPO processing at DTC. This session also includes screen shots and explanations of the associated PTS functions. Discussion topics include:

- The purpose of DTC's stock loan and repurchase agreement (REPO) tracking system
- When stock loan and repurchase agreement (REPO) tracking occurs
- Common reasons for out-of-balance conditions
- The tools available to research out-of balance conditions
- How to correct out-of-balances

Introduction to Settlement (Session 1): Overview of DTC Settlement and Concepts of Risk Management is a two-hour Webinar session, led by a DTCC Learning training expert, designed to provide learners with an understanding of the concepts, terminology and fundamentals of DTC settlement

processing and the risk management controls supporting the system. This session also includes screen shots and explanations of the associated risk management PBS applications. Discussion topics include:

- Requirements for using the DTC Settlement Service
- How transactions are recorded in a participant's account
- How settlement occurs at DTC
- DTC collateralization
- Risk management controls and how to make inquiries
- Why transactions recycle and how to respond
- PBS applications used to perform risk management activities

Introduction to Settlement (Session 2): Settlement Transactions, Systems and End-of-day process is a two-hour Webinar session, led by a DTCC Learning training expert that builds on the concepts from session one and introduces terms, systems and processes associated with Settling transactions at DTC. This session also includes screen shots and explanations of the PBS applications used for settlement transactions. Discussion topics include:

- Deliver orders, payment orders, reclaims and collateral loans
- The reasons for each of these transaction types
- How to process a deliver order and payment order
- The purpose of the following systems:
 - Inventory Management System (IMS)
 - Receiver Authorized Delivery (RAD) System
 - Account Transaction Processor (ATP)
- How to approve/cancel a transaction in RAD
- How to process a reclaim using the Activity Research Tool
- The responsibilities of participants and settling banks during end-of-day settlement
- The purpose of the Consolidated Settlement System
- How the Participant Account Statement is used for balancing accounts
- The timeframes associated with the end-of-day processing schedule
- Using PBS applications in conjunction with settlement transactions activities

A certificate of completion will be awarded to attendees of either session. Attendees with Certified Securities Operations Professional (C.S.O.P.) certification from the Institute of Certified Bankers will earn continuing education units (CEUs).
