In order to ensure a high percentage of responses, LOFFs should only be sent to those brokers appearing on the listing as respondents. **It is necessary to browse the PEXR function daily to see incoming messages, since tickets will only be generated on the originator's and receiver's printers when receivers respond.**

Updated listings will be distributed periodically as additional broker/dealers begin to use the service.
